HIGHWAY TRAFFIC ACT

**TOWN OF LOURDES REGULATIONS
DEPARTMENT OF
TRANSPORTATION AND WORKS**

ORDER

1. In accordance with the provision of section 189, the *Highway Traffic Act*, RSNL 1990, cH-3, power is hereby delegated to the Town of Lourdes to make regulations to have effect only within the limits of the municipality and only in respect of those roads, streets, lanes, sidewalks and bridges within the municipality, the ownership, management or control of which is vested in the municipality, for any of the purposes of section 189.

2. In accordance with the provisions of section 190, the *Highway Traffic Act*, RSNL 1990, cH-3, approval generally is given the Council to exercise the power, with respect to particular traffic signs or classes of traffic signs to place traffic signs on a road, street, lane, sidewalk or a bridge, within the municipality as per section 190.
3. This authority is restricted to non-moving violations only.
4. In Witness Whereof I have set my signature and caused the Seal of the Department of Transportation and Works to be affixed at St. John's, in the Province of Newfoundland and Labrador the 12th day of December, 2011.
