A PROCLAMATION

WHEREAS under section 128 of the *Constitution Act, 1867*, I, as Lieutenant Governor of the Province of Newfoundland and Labrador, am authorized to administer the Oaths or Affirmations of Allegiance to Her Majesty Queen Elizabeth II to those persons elected to be Members of the House of Assembly in the General Election held on November 30th, 2015;

AND WHEREAS under section 5 of the *House of Assembly Accountability, Integrity and Administration Act*, I, as Lieutenant Governor of the Province of Newfoundland and Labrador, am authorized to administer an Oath or Affirmation of Office to those persons elected to be Members of the House of Assembly in the said General Election;

AND WHEREAS the said sections of the *Constitution Act, 1867* and the *House of Assembly Accountability, Integrity and Administration Act* further require that the persons declared elected as Members during the General Election held on the said date must take their Oaths or Affirmations of Allegiance and Oaths or Affirmations of Office before they can take their seats in the House of Assembly;

NOW THEREFORE, I, the Lieutenant Governor of the Province of Newfoundland and Labrador, do authorize and direct you, the said Sandra Barnes and Elizabeth Murphy, or either of you, to request that the Members Elect gather in the House of Assembly Chamber on Friday, December 18th, 2015 at 10 o'clock in the morning in order to take their Oaths or Affirmations of Allegiance and Oaths or Affirmations of Office before me.
