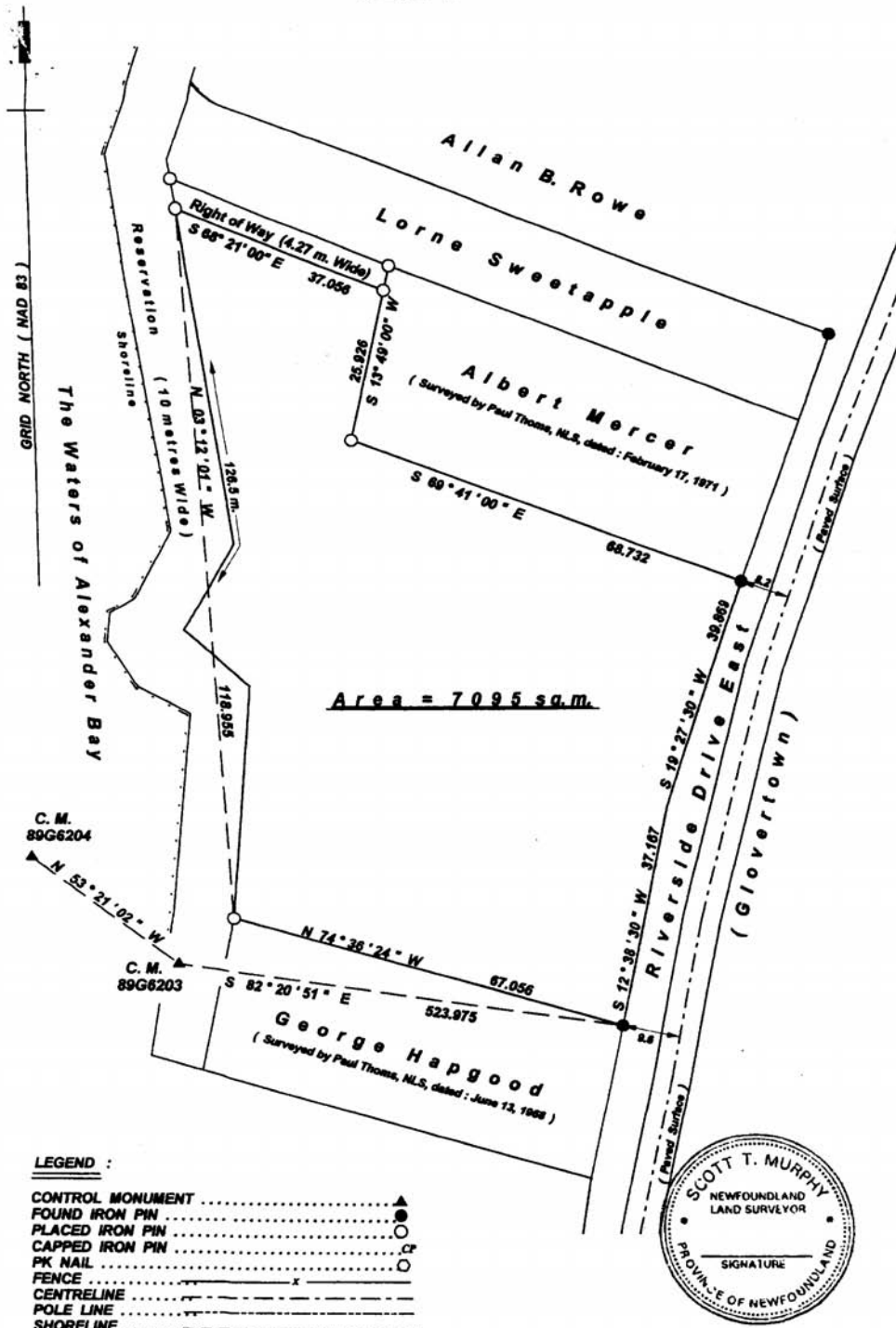

Then following said watershed boundary in a counter-clockwise direction, South 8° 00' East, 700 meters, South 43° 00' West, 500 meters, North 83° 00' East, 750 meters, North 35° 00' East, 2250 meters, to a point on the northwest corner of said watershed;

Then north 27° 00' east, 1,650 meters, more or less, to a high point;

Then north 20° 00' west, 850 meters, more or less, to a high point;

Then due west, 1,800 meters, more or less, to a point on the highwater of Tickle Bay, Trinity Bay;

Then in a general southwesterly direction, following the sinuosities of the shoreline of Tickle Bay/Broad Lake, to the point of Beginning.

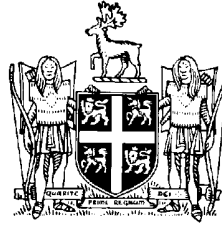

Then in a southwesterly direction along a line parallel to and 300 metres from the said shoreline to a point on the western shoreline of an



unnamed brook flowing into the Exploits River, said point being south 72° 03' west, 13913 metres, more or less, from the last given point;

Then in a northerly direction along the western bank of said brook to a point on the southern shoreline of the Exploits River;
