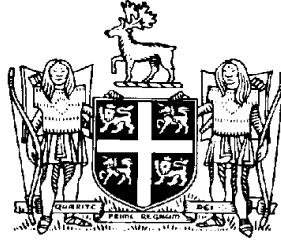

*Notice of Protected Water Supply Area of
American Pond, WS-S-0363
under the
Water Resources Act*

Under the authority of section 39 of the *Water Resources Act*, I designate the area generally known as the *American Pond Water Supply Area, WS-S-0363*, for the Town of Hopedale as a protected water supply area.
