NOTICE OF REGISTRATION TOWN OF CHARLOTTETOWN MUNICIPAL PLAN AMENDMENT No. 1, 2005, and DEVELOPMENT REGULATIONS AMENDMENT No. 1, 2005

Take notice that the Town of Charlottetown Municipal Plan Amendment No. 1, 2005, and Development Regulations Amendment No. 1, 2005, approved on the 16th day of November, 2005, has been registered by the Minister of Municipal Affairs.

In general terms, the purpose of the Municipal Plan Amendment No.1, 2005, will consist of a transfer of the digital Future Land Use Map layer to new digital mapping. The new watershed boundary and access road, Route 514, to the Trans Labrador Highway and to Pinsent's Arm has been added to the Future Land Use Map 1 and 2. The "Commercial", "Residential" and "Mixed Development" land use designations have been expanded. The "Commercial" land use designation has been expanded westward along the limits of the new Charlottetown access road, Route 514. The "Mixed Development" land use designation has also been expanded from the "Environmental Protection" designation in the north east area of Town in the area of the former watershed protection area. The "Residential" designation has been expanded in the north east section of Town.

Development Regulations Amendment No. 1, 2005, will consist of a transfer and re-zoning of areas onto new digital mapping. The same areas as designated on the Future Land Use Maps 1 and 2 are reflected in the Land Use Zoning Map 1 and 2.

The Town of Charlottetown Municipal Plan Amendment No. 1, 2005, and Development Regulations Amendment No. 1, 2005, comes into effect on the day that this notice is published in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of the Town of Charlottetown Municipal Plan Amendment No. 1, 2005, and Development Regulations Amendment No. 1, 2005, may do so at the Town Office, Charlottetown, during normal working hours.

1. (1) Subsections 187.1(1) and (1.1) of the *Occupational Health and Safety Regulations* are repealed and the following substituted:

Diving standards

187.1 (1) The following standards respecting diving operations, including amendments to them, are adopted and constituted as part of these regulations:

- (a) CAN/CSA-Z275.4-02 "Competency Standard for Diving Operations"; and
- (b) CAN/CSA-Z275.2-04 "Occupational Safety Code for Diving Operations".

(1.1) Notwithstanding paragraph (1)(a), the following modifications to CAN/CSA-Z275.4-02 "Competency Standard for Diving Operations" apply to seafood harvesting and aquaculture diving operations:

(a) clause 7, SCUBA Supervisor (Restricted and Unrestricted) is struck and the following substituted:

- (i) Individuals who have successfully completed a five-day Surface Safety Attendant's course approved by the Workplace Health, Safety and Compensation Commission may supervise seafood harvesting and aquaculture diving operations.

(2) Subsection 187.1(3) of the regulations is repealed.
