Take notice that the Town of Conception Bay South Municipal Plan Amendment No. 12 and 13, 2005 and Development Regulations Amendments No. 16 and 17, 2005, adopted on November 8<sup>th</sup> 2005 and approved on December 6<sup>th</sup> 2005 has been registered by the Minister of Municipal and Provincial Affairs.

In general terms, the purpose of Municipal Plan Amendment No. 12, 2005 is to redesignate property at 1487-1499 Conception Bay Highway, Seal Cove to the Industrial Land Use Designation. The corresponding Development Regulations Amendment No.16 will rezone the property to the Commercial Light Industrial Land Use Zone. The purpose of Municipal Plan Amendment No. 13, 2005 is to redesignate land at 672-674 Conception Bay Highway, Kelligrews, from the Residential Medium

Density Land Use designation to the Mixed Development land use designation. The corresponding Development Regulations Amendment No. 17 will rezone the property to the Residential Mixed land use zone to accommodate development of a barbershop as an extension to the existing dwelling.

The Conception Bay South Municipal Plan Amendment No. 12 and 13, 2005 and Development Regulations Amendments No. 16 and 17, 2005 will come into effect on December 16<sup>th</sup> 2005, the date of publication in *The Newfoundland and Labrador Gazette*. Anyone who wishes to inspect a copy of these amendments may do so at the Town Office, during normal working hours.
