In general terms, the purpose of Development Regulations Amendment Number 155, 2005 is to re-zone this property to the rear of 59 Clyde Avenue from Recreational Open Space (OS) to Industrial-Light (LI). These amendments would accommodate the expansion of the City Depot facility.

In general terms, the purpose of Development Regulations Amendment Number 159, 2005 is to bring this commercial zone in line with most other commercial zones with respect to Taxi Stands in the City and to respond to a recent request for a taxi stand use at 1 Olympic Drive.

In general terms, the purpose of Development Regulations Amendment Number 160, 2005 is to reduce the maximum number of persons that are permitted to be accommodated in a family or group care centre from six (6) to four (4) persons, exclusive of staff.
