**1. Subsection 8(3) of the *Registered Nurses Regulations* is repealed and the following substituted:**

- (a) that he or she has an arrangement with a physician for the purpose of consultation with respect to the care of a patient;
- (b) the name and address of the physician;
- (c) the date he or she entered into the arrangement with the physician; and
- (d) that the care of a patient may be transferred to the physician.
